

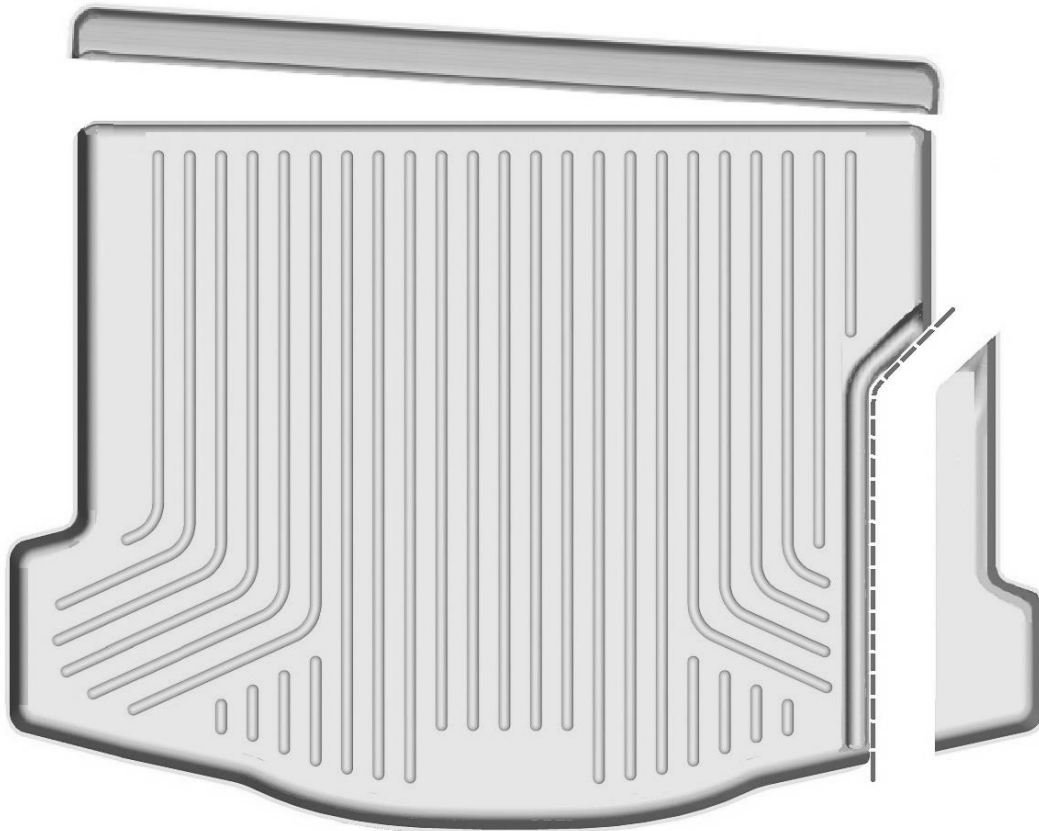
HUSKY **WeatherBEATER™** **Custom Vehicle Floor Protection**

CARE AND USE INSTRUCTIONS

Thank you for selecting a WeatherBeater Trunk Liner from Winfield Consumer Products. Your new trunk liner is custom molded to fit your Ford Focus 5-door hatchback. Upon removal from the box your liner will not completely unroll and lay flat. This is normal and only temporary. Just place the liner on the floor or in the trunk of your vehicle with a weight in each corner (a book works well). After about 15 minutes, your liner will remain flat. In colder climates this “relaxing” may take longer; moving the liner to a heated area will accelerate the process.

Your liner is manufactured using an engineering resin that is lightweight and extremely tough and durable. The easiest way to clean your liner is with a damp cloth or sponge. If using a cleaner, 409® or Glass Plus® work well. Use of Armor All®, Son-of-a-Gun® or similar items is discouraged as these products make the liner slick.

INSTALLATION INSTRUCTIONS FOR YOUR FORD FOCUS 5-DOOR HATCHBACK TRUNK LINER



AS BOXED, YOUR LINER WILL NOT FIT FOCUS MODELS WITH A FACTORY SUBWOOFER IN THEIR TRUNK COMPARTMENT. YOUR LINER IS DESIGNED TO ACCOMMODATE THE SUBWOOFER VIA TRIMMING. TO TRIM, LOCATE THE MOLDED IN STEP IN THE LINER THAT ACTS AS A TRIMMING GUIDE (SEE DIAGRAM ABOVE / PHOTOS ON BACK OF PAGE). THEN, USING HEAVY SHEARS OR A UTILITY KNIFE, REMOVE THE AREA OF LINER THAT THE SUBWOOFER WILL OCCUPY.

YOUR FOCUS MAY ALSO HAVE A “FULL SIZE” SPARE TIRE IN PLACE OF THE SMALLER STANDARD SIZE SPARE TIRE. IF YOUR VEHICLE HAS THE FULL SIZE SPARE THE CARGO FLOOR SITS HIGHER THAN MODELS WITH THE SMALLER SPARE. YOUR LINER WILL FIT EITHER CONFIGURATION.

TO ALLOW FIT WITH THE LARGER SPARE A TRIM IS INCORPORATED INTO THE RAISED FRONT PORTION OF THE LINER. AFTER TRIMMING THE LINER WILL INCLUDE A RAISED CONTAINMENT WALL. TO TRIM, USE HEAVY SHEARS OR A UTILITY KNIFE AND FOLLOWING THE TRIM STEP MOLDED INTO THE PART REMOVE THE TRIM AREA AS SHOWN IN THE DIAGRAM ON THE FRONT PAGE AND IN THE PHOTO ON THE LAST PAGE.

Return alleged defective part to the place of purchase for replacement or refund. Please have a copy of your purchase receipt available when you call. The foregoing is the only express warranty made by the manufacturer and is limited to the duration of this warranty. **ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE IS LIMITED IN DURATION TO THE DURATION OF THIS WARRANTY. LABOR CHARGES, INJURIES, OR ANY OTHER LOSS OR DAMAGES WHATSOEVER, INCLUDING THOSE INCURRED IN INSTALLATION ARE EXCLUDED. ADDITIONALLY, PAINTING OF REPLACEMENT HUSKY LINER PARTS AND ANY VEHICLE COMPONENT REPAIR OR REPLACEMENT AS WELL AS INCIDENTAL DAMAGES ARE EXCLUDED.**

This warranty is void for damages to the product due to misuse, abuse, neglect, accident, improper installation or any use that violates the instructions furnished by us.

ABNORMAL WEAR AND TEAR ARE NOT COVERED UNDER THIS WARRANTY. Obviously, if your dog chews up your Husky Liner product, it's not covered under the warranty. Likewise, if you shut your Husky Liner in the door of your vehicle, damage to the liner and/or door are not covered. Commonplace, everyday wear on a particular product is considered normal, and is not covered under warranty repair.
